July 27, 2006, "On personal data" hereby confirms that personal data provided (to be provided) in documents submitted (or to be submitted) to Evrofinance Mosnarbank (location: 29 Novy Arbat Street, Moscow 121099, OGRN (Primary State Registration Number) 1027700565970, General Banking License No. 2402 dated July 23, 2015, License of a professional participant of the securities market to carry out depository activities No. 045-04142-000100 dated December 20, 2000 (hereinafter also referred to as the "Depository"), are submitted to the Depository for processing (as per our instruction) by means of performing actions (transactions) or a set of actions (operations) performed using a hard copy and/or on digital media as follows: collecting, recording, systematization, accumulation, safekeeping, clarification (updating, changing), retrieval, usage, transfer (provision, access), including the transfer to persons with whom the Depository has contractual relations depersonalization, blocking, deletion, destruction, using automation means or without using thereof, using (but not limited to) the following main methods: safekeeping, recording on hard copy and electronic media and their storage, listing, labeling;  
processing of personal data is carried out by the Depository for the following purposes: Depository's implementation of the functions assigned by the legislation of the Russian Federation, including capital market regulations, and also for the purposes of making decisions on the possibility of opening a custody account, other accounts used in the provision of custody services, including the evaluation of fairness of the data provided by the Company when applying to the Depository and in the documents provided, for the conclusion of any transactions related to the opening of a custody account, other accounts used in the provision of custody services, and their further performance, including the disposal of securities on these accounts both through a hard copy and using an electronic remote banking service system, conclusion and execution of other transactions, making decisions or performing other actions that give rise to legal consequences for the Company or other persons, the implementation (performance) of the Depository's rights (duties) provided for by the legislation of the Russian Federation on managing custody accounts, other accounts used in the provision of custody services, safekeeping, including in electronic form, for the purpose of ensuring the Client's and Depository's security, transportation and protection of personal data received for the aforementioned purposes;  
have been acquired by the Company in accordance with the requirements and procedures stipulated by the legislation of the Russian Federation on personal data, while no restrictions known to Company on its processing

by the owner of personal data have been established, the owners of personal data have been notified of the processing (list of actions (operations) and the description of methods is specified above) by the Depositary of their personal data for the above purposes, which is carried out by the Depositary in compliance with the principles and rules for the processing of personal data stipulated by the Russian Federation law on personal data, with the mandatory observance of the confidentiality of personal data and ensuring the security of personal data during processing, and agree with it.
