The Bank has the right to independently determine the executing mode for payment instructions in the period stipulated by the Banking Account Contract. In such a case, the Bank does not charge banking fee and applies tariff according to the num. 2.1.3

Executing of payments after the close of banking day is possible if the payment instruction received until 18.00 MT on Mondays-Thursdays and until 17.00 MT on Fridays and before holidays

<sup>3</sup> Executing of payments with the 1st run is possible if the payment instruction received until 10.30 MT, with the 2<sup>nd</sup> run, if received until 13.30 MT, and with the 3d run, if received until 15.30 MT

Executing of payments after the close of banking day is possible if the payment instruction received until 18.00 MT on Mondays-Thursdays and until 17.00 MT on Fridays and before holidays
